The proposed manager of the restaurant also manages Saugus, North Andover and Reading. Mr. Latham also offered recommendation letters from the above cities. The applicant proposes to renovate the 6588 sq ft area at the Village Mall, 436 Broadway. The floor plan has been submitted to the board. The common victualler license will be in operation Monday through Sunday 11:00 am – 10:00pm. Mr. Latham has enclosed Mr. Boland's resume and also the menu. At that time, Atty. Latham asked there were any questions.

Mr. Piemonte motioned to approve the application for wine and malt, common victualler, and entertainment with the contingency that the Police forward the approved check list.

Mr. MacLeod seconded the motion for the Boland Group IV, LLC dba/Fuddruckers, 436 Broadway contingent upon the city check lists being approved as the various stages of construction are completed. Mr. MacLeod also commented on the application so detailed and well thought out.

Atty. Latham also notified GLEC School of the application.

Mr. Foderaro asked for proposed opening with a response from Atty. Latham that construction will start mid June with an approximate opening of mid October beginning November.
