FIREARMS LAWS

140 - 131	License to carry or possess firearms
140 - 131A	Permits to purchase, rent or lease firearms, or to purchase ammunition; fee; penalties
140 - 131B	Penalty for loan of money secured by weapons
140 - 131C	Carrying of firearms in a vehicle
140 - 131D	Repealed, 1954, 672, Sec 7
140 - 131E	Purchase by residents; licenses; firearm identification cards; purchase for use of another; penalties; revocation of licenses or cards; re-issuance
140 - 131F	Non-residents or aliens; temporary license to carry firearms or ammunition
140 - 131F½	Theatrical productions; carrying firearms and blank ammunition
140 - 131G	Carrying of firearms by non-residents; conditions
140 - 131H	Ownership or possession of firearms by aliens; penalties; seizure and disposition
140 - 131I	Falsifying firearm license or identification card; penalty
140 - 131J	Sale or possession of electrical weapons; penalties
140 - 131L	Security of weapons; penalties; MUST be secured (This is new to the firearms law - Click here)
269 - 10	Carrying dangerous weapons, possession of machine gun or sawed-off shotgun
269 - 10H	Carrying a firearm under the influence; loaded firearm (This is new to the firearms law - Click here)

269 - 11B	Possession or control of firearm with serial or identification number removed or mutilated
269 - 11C	Removal or mutilation of serial or identification numbers of firearms
269 - 11E	Serial identification numbers on firearms; penalties
269 - 12A	Selling or furnishing an air rifle to minor
269 - 12B	Possession of air rifle by minor under eighteen; shooting air rifle
269 - 12E	Discharge of firearm within 500 feet of dwelling or other building in use
